1. INTRODUCTION

- 1.1 The Procurement Reform (Scotland) Act 2014 Section 18 States that regulated organisations must prepare an Annual Procurement Report on its regulated procurement activities as soon as reasonably practicable after the end of the financial year.
- 1.2 This is the Association's sixth annual procurement report and it covers the period 1 April 2022 to 31 March 2023.
- 1.3 The Association has a Procurement Strategy, a Procurement Policy and a Contracts Register which is regularly updated and published on the Association's website.
- 1.4 It has been reported previously (Director of Investment's Report, dated 19 September 2016) that the Association underwent a Procurement Capability Assessment (PCA) on a free, pilot basis, provided by Scotland Excel.
- 1.5 In May 2017, the Scottish Government introduced the Procurement Improvement Programme for the Housing Sector. The Association engaged with Scotland Excel in this process and has completed a "Procurement and Commercial Improvement Programme" lite (PCIP lite) assessment which was reported to Members on 21 May 2018.
- 1.6 It should be noted that an Annual Procurement Report, recording and publishing the Association's performance and achievements, must be published on our regulated procurements (Regulated thresholds are £50,000 for Goods and Services and £2,000,000 for Works and have not changed as per the current Scottish Government on-line advice at the time of writing) as soon as reasonably practicable after the end of the financial year and no later than four months thereafter i.e. the end of July 2022. The report must include:-
 - A summary of the regulated procurements that have been completed during the year covered by the report;
 - A review of whether those procurements complied with the Association's Procurement Strategy;
 - The extent to which any regulated procurements did not comply, and a statement detailing how the Association will ensure that future regulated procurements do comply;

- ➤ A summary of community benefit requirements imposed as part of a regulated procurement that were fulfilled during the year covered by the report;
- A summary of any steps taken to facilitate the involvement of supported businesses in regulated procurements during the report period;
- A summary of regulated procurements expected to commence in the next two financial years.
- 1.7 Once approved by Members, this report will be published on our website and then Scottish Ministers will be notified by email to annualprocurementreport@gov.scot with a link to where this report can be accessed.

5. SUPPORTED BUSINESS SUMMARY

5.1 The Association can let contracts to supported businesses as set out in our Procurement Policy. A supported business is one where at least 30% of the workers are disabled persons who by reason of the nature or severity of their disability are unable to take up work in the open labour market. No regulated procurement was awarded to supported businesses during the period of this report.
